**Policy Title:** Extra-Curricular Policy

**Policy Statement:**

For an extra-curricular program to be continued or to institute a new program, the program must:

1. Contribute to the following Kentucky Learning Goals:
  - a. Becoming a self-sufficient individual
  - b. Becoming responsible members of a family, work group, or community, including demonstrating effectiveness in community service.
2. Generate and maintain student interest as well as attract students currently not involved in extracurricular or service projects.
3. Encourage, enhance, and maintain equity including but not limited to a wide range of opportunities for both male and female students
4. Have a suitable adult sponsor and have appropriate adult supervision at all times

Programs offered:

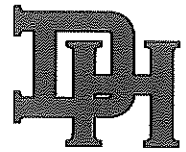

Student participation:

Students will be eligible to participate in extracurricular activities if they:

- Maintain passing grades in 66% of all classes (for trimester schedule that is 4 out of 5 classes)
- Were in attendance at least 0.5 day on the day of the activities or on Friday for weekend activities unless approved by an administrator
- Comply with rules established by the adult coach or sponsor for the activity.

- Where applicable, meet any requirements set by the appropriate sponsoring or governing organization.

**Coaches and Sponsors**

Each extracurricular activity will be led by an adult coach or sponsor who meets any applicable requirements set in the law, or by sponsoring or governing organization, such as the Kenton County Board of Education. The coach or sponsor will be responsible for personally supervising or ensuring that all students are supervised by an adult while they are participating in the activity, including practice time and travel time where applicable.

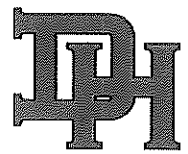
