- 1. Review and Approve Agenda-Nikki Cottengim made a motion to approve the agenda. Carla Oetinger seconded the motion. The agenda was approved with consensus from the Council.
- 2. Review and Approve July 23, 2020, meeting minutes-Nikki Cottengim made a motion to approve the minutes. Jessica Fisk seconded the motion. The minutes were approved with consensus from the Council.
- 3. Public Comment- No Public Comment
- 4. Review and Approve Special Education Teacher Interview Questions-Amanda Higgins made a motion to approve the interview questions. Carla Oetinger seconded the motion. The questions were approved with consensus by the Council.
- 5. Closed session to interview for Special Education Teacher (posting #1853) pursuant KRS 61.810 (1)(k) Meetings which federal or state law specifically require to be conducted in privacy.
